Greenleaf Barn 2021 Dream Wedding Giveaway - Vendor Agreement

- **1. Vendor Agreement** This agreement, properly executed and understood by applicant (Vendor), and shall, upon written acceptance constitute as a valid and binding agreement.
- 2. Vendor Donation Vendor has voluntarily agreed to participate in the Dream Wedding Giveaway contest sponsored by Greenleaf Barn, LLC by donating services/good to the giveaway. Vendor agrees to provide those services/goods at a date agreed upon by the majority of all vendors but ultimately decided by Greenleaf Barn, LLC. After a winner is selected, dates will be narrowed down by the availability of vendor majority. The vendors with less flexibility will be accommodated first (ie. Their company is only one person. They only have one product to use at a time.) Winners are informed that depending on the date they select, one or more vendors may not be available. If the majority of vendors selects a date and a vendor is not available, Vendor has met the contractual obligations of this agreement.
- **3. Marketing** Vendor agrees to cross promotion of Dream Wedding Giveaway through social media outlets with a minimum of 3 posts. No marketing photos will be used not shot at Greenleaf Barn. Vendor will provide description and photo or video via email (greenleafbarnok@gmail.com) to Greenleaf Barn before March 1, 2021 for cross marketing purposes.
- **4. Cancellations** In the event a conflict arises from other business engagements 30 days prior to the wedding date, vendor agrees to make every effort to provide agreed upon services/goods not limited to: substituted goods or another vendor to replace services. If cancellation notice is made within 30 days of the event date, vendor agrees to provide comparable replacement for good/services.
- **5. Liability** This agreement shall not constitute or be considered a partnership, employer-employee relationship, joint venture or agency between Greenleaf Barn, LLC and Vendor. Vendor hereby agrees to and does indemnify, hold harmless and defend Greenleaf Barn, LLC, and their respective agents and officers, and facility from and against any and all liability, responsibility, loss, damage, cost or expense of any kind whatsoever (including but not limited to cost, interest and attorney's fees) which Greenleaf Barn, LLC may incur, suffer, be put to, pay or be required to pay, incident to or arising directly from any act or omission by Vendor of any of its employees, servants, or agents. Vendor further agrees that Greenleaf Barn, LLC, its agents, officers, successors, and their respective agents, employees and the facility shall not be responsible in any way for (a.) damage, loss or destruction of any property of Vendor, or (b.) injury to Vendor or its representatives, agency, employees, licensees or invitees.
- **6. Warranties -** It is expressly recognized and understood that Greenleaf Barn, LLC makes no warranties, representations, or commitments regarding the number of vendors participating in the wedding giveaway contest. Greenleaf Barn, LLC shall not be liable for loss or damages that may be

caused by poor participation or any other circumstances that vendor may deem to have adversely impacted their participation in the contest.

- **7. Compliance** For the wedding event, vendor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorized Local, State, and Federal governing bodies concerning fire, safety, health, and all applicable taxes together with the facility rules and regulations and the display rules and regulations issued by Greenleaf Barn, LLC staff.
- **8. Management** Vendor further agrees that the conditions rules and regulations are a part of the contract and that said Vendor agrees to be bound by each and all of these conditions, and that Greenleaf Barn, LLC shall have the full power to interpret, amend and enforce all rules and regulations in the best interest of the giveaway.

In consideration of acceptance, I hereby, waive all rights, and claims I may have against Greenleaf Barn, LLC, the sponsors, coordination group, and any individuals associated with this giveaway and their property owners with said event. I give permission for the free use of my name and picture in any broadcast, telecast or print/digital media account of this application. By signing this form, I acknowledge that I have read and fully understand my own liability and accept all rules and responsibilities as a participant vendor.
